# 2. Pathway Progress Sheets

Update the Advisory Committee regarding the status of the updates to the AUTO and ACRT pathway sheets. Showed the committee the location of the pathways sheets on the COM webpage.

### 3. NATEF Certification

Ron gave an update on the countertops which have begun to be installed, floors are scheduled for early December, tools have all been received, curriculum meets NATEF guidelines, policies and procedures that are required for NATEF certification. All the policies, procedures are in place. We have the liability waiver on our invoices as required by NATEF. We need to hire someone to update the tool boards in the shops. The next step will be the internal check of all things that are required for NATEF certification.

Kathy Takemoto is working on the outcome/job employment information required for NATEF certification, they require five years of information. We expect to do a self-study next semester and invite NATEF for an official visit in the Fall 2016 semester.

Industry wanted to know what was taking so long to get things ready for the certification. At an Educational institution there are processes that are sometimes cumbersome that need to be followed.

There was discussion about the difference in the last 10 years in obtaining NATEF certification. Renewal is a much more streamlined process than the original application.

Unfortunately processes take longer in a public institution.
