Community Updates	10:15	Fire Advisory Members	Background Recap: Currently employed firefighters are not receiving degrees, consequentially not eligible for promotions to management after going into the workforce. Since last Advisory meeting, COM has been looking at building out an Associate Degree online program in Public Safety at COM, and wanting to link it to a baccalaureate degree. The industry feels that COM can support this with existing classes and classes offered by the Fire Department. The attrition may come from - Lack of academic readiness - students have hesitation about going back to school - fire fighter's low motivation of completing a Liberal Arts degree	Action: Angela would like to pilot the AS degree program; the 1 st step is surveying the fire station officers A pilot cohort will be at least 15 students, in the aim of starting in Fall 2019

All agreed that COM offering a AA or AS degree in Public Safety is a great idea. Open Discussion	10:15	Discussions on how to award students with credits based on their training, certificate courses and work experience. Fire fighters need "S" classes – certificate – S290 – being certified by Matt Cobb. 12-week fire academy, builds on Fire 1 academy – would be great to get college credit for these classes. Recognizing State Fire Certificates and applying it to the COM degree. SRJC already does this. Fire 255 Wildland (COM) – coming back in the future - with the tightened budget, Fire 255 may be reactivated on the Catalog but will not receive teaching units in the budget - If reactivated, student could petition equivalency evaluation to receive credits for Wildland	Reviewing State fire training courses to see if there are any equivalents to COM's courses. Certificates definitely align with COM units (can be listed as electives)

Can resumes be turned in for unit credit? Can we waive the Health fee?

John Hancock College and Cal Poly offer degrees utilizing the Fire academy classes as credit. John Hancock has list of CSU credit classes also Sacramento and Humboldt already offer.

Basic EMT certificate graduates are eligible to enroll in: EMS, Fire Rescue, Wildland; Fire courses 130, 131, and will receive a Red Card and they can be hired right away.

Can an evaluation of work already completed (both Fire classes and on-the-job experience) be reviewed before signing up for COM? Can resumes be turned in for unit credit?

Baccalaureate degree is required for officers.

Discussion on skills needed

Fire calculations are algebra, medical

-COM has a new math pathway – business focused, not online right now.

Interpersonal skills classes are important for firefighters to on the front line.

 COM has communication classes, however all of the COM communications classes are "in-class" courses and do not flexible schedules. It would be too hard to have the class online.

Officers are required to take leadership classes - L180, L280, 381-Graham Groneman teaches – Mission Center solutions private COM has a contract with Palos Verdes allowing them to practice their services in our area since we do not offer the same opportunity that they current do.

Brett McTigue will send a spreadsheet of all of classes from Hancock and the current training offered at the Fire Academy.

Fire Chiefs will collaborate and develop an evaluation grid to guide assigning credits to resumes, certificate classes and other trainings.

- Students cannot switch tracks from Fire to Nursing if taken
 A&P combined
- SRJC has A&P class 4 units, only for Paramedic program.

Recommendation: Paramedic Program

Advisory members presented the strong need of Paramedics in the workforce

- The Marin Fire Departments are always looking to hire paramedics.
- Helps Fire students fast-track into a fulltime career
- Local Marin students are moving to Redding and Southern California to attend Paramedic classes
- It would be a great miss for COM if not building a Paramedics program now

Brett and Graham talked about the Paramedics programs in the area and their common barrier-difficulty to place internship

- Marin Fire Departments can support 2 internships a year but want to hire 4.
- Need to promote more internships.
- Need Fire Chiefs to approve. Union issues, preceptor, etc..
- Opportunity to change the internship model. Now 100% on ambulance, maybe change to some time on engine too. But need to transport patient.

COM Nursing department has the skills labs already, maybe we can leverage it? Also maybe utilize nursing lab and faculty or have Fire Chiefs come in as adjunct faculty.

Mike Single – connect about teaching.

Create partnerships with volunteer opportunities in Marin County between COM and the Fire Departments; creates buy-in and interest for students.

Angela stated COM needs a solution of breaking the clinical placement barrier before building the Paramedics Program - Graham: Marin County can take 15 interns every 3 month (5 interns per shift, 3 shifts total); a solution would be Fire Chiefs to be partner with COM and give exclusive placements and priority to COM's students - Hospital placements are not an issue, already have partnerships and space to accommodate Volunteer Opportunities Brett presented that County is very committee to the Volunteer Program.
