Quality of education has not been compromised. 7 Full-time faculty, maximum 86 students. ➤ Health Sciences Reorganization: Addition of Program Administrator position, operational and logistical support across all programs. Implement Chair designation for Nursing. ➤ Clinical Placements & Preceptorship/Community: Moving into the community, clinical opportunities, improved two-way communication with partners. Emphasis on hospital communities, local nurses. Adult learning strategies to elevate practice. Aging Marin population. Learning time management, clinical judgement. Mentoring. ➤ BSN Programs Collaboration & TTP: College of Marin partnership with University of Phoenix new this year and Sonoma State University (SSU enrollment 15 this year, normally cap at 11). High level of participation. Encourage BSN. Kaiser. Education to Practice programs. Challenges of employment trends, graduate survey to show where our graduates are employed. ➤ Operational Support ➤ NCLEX-RN Results: Drop in pass rates in 2014-2015. Discussion that this drop was nationwide. Discussion of value of additional NCLEX prep classes. Pass 31/34, historical rise ➤ ATI Data and Student Learning Outcomes: ATI Pulse normed nationally, 93% COM's first years currently probable to pass NCLEX. Interesting analysis to move predictors back in time to identify at-risk students earlier. Make remediation a work in progress. Learn to think critically, synthesis of information, skills. Leads to better test results. ➤ Nursing Education Plan White paper: distributed for review. 6 recommendations 	-Define reporting elements
